

# As of July, 2006 these are the current numbers and amounts regarding sexual misconduct allegations, settlements and legal fees.


Since the Archdiocese of Miami was founded in 1958, allegations of sexual misconduct involving minors have been made involving 44 priests, which is less than 1% of the 4,393 priests who have served in the Archdiocese.




The Archdiocese of Miami Insurance Programs have reported 12,860 claims since 1966 (when the Insurance Programs were established) as follows:

## Church continues efforts to Protect children

From the archdiocese

Working together with civil officials, religious leaders and all persons of good will, the Archdiocese of Miami continues to move forward in its commitment to protect children and vulnerable adults.

The information on this page and on page A27 of this edition of The Florida Catholic is part of that commitment. This is the third in a series of reports outlining the legal and insurance costs associated not just with sexual abuse lawsuits but with all insurance claims against the archdiocese. The others were published in December 2003 and January 2005.

Once again in 2005, an independent team of auditors found that the archdiocese's policies and practices in this area were in compliance with the Charter for the Protection of Children and Young Adults established by the bishops of the United States and approved by the Holy See.

In keeping with the charter, the archdiocese is committed to training all its employees and volunteers, as well as parents, grandparents and other family members, to recognize the danger signs of sexual abuse of minors and learn about specific steps they can take to identify abuse and prevent it.

The training program for adults, now in its third year of use in the archdiocese, is called Virtus. A similar training program, "Teaching Touching Safety," implemented two years ago, also teaches children, in age-appropriate ways, how to protect themselves from potential abusers. More than 11,000 adults and 56,000 children have

undergone the Virtus and Teaching, Touching Safety programs, respectively.

The archdiocese also requires all church employees, including religious, priests and deacons, to undergo a criminal background check at both the state and national levels. The same background check is required of any volunteer who spends any unsupervised time with children or vulnerable adults. Since 2004, background checks have been conducted on 17,390 archdiocesan employees and volunteers, including priests and religious.

Archbishop John C. Favalora hopes the reports printed in *The* Florida Catholic will help restore parishioners' confidence in the church's efforts to address the problem of child sexual abuse, which continues to make news in our society.

When the accusation has been proved to be unfounded, every step possible will be taken to restore the good name of the person falsely accused.

"While it is most scandalous when a member of the Catholic clergy or another representative of the church commits this sin against a child, young adult or vulnerable adult, the sexual abuse of minors is not an exclusively Catho-
